I tend to do this work by way of the Bar's Public Access Scheme but am occasionally instructed by solicitors to advise and act on their behalf in these matters.

<u>I do not deal with</u> Employment Tribunal cases, financial disputes arising out of divorce, Immigration Appeals (First Tier Tribunal), Inheritance Act advices, Licencing Applications in respect of Business Premises, Personal Injury Claims or Winding-up Petitions <u>under the Public Access Scheme</u>.

I will provide you with a quote as soon as possible. I always aim to set out quotes clearly, but if you receive your quote and there is something you do not understand, please contact me.

Many prospective clients contact me via <u>www.stokenewingtonchambers.co.uk</u> where telephone conference appointments can be scheduled without the need for emailing first.

I am also a Door Tenant at Holborn Chambers. A "door tenancy" means that you can also contact me there. Please see the bottom of this page for Holborn Chambers' postal address.

Your investment (Fees)

Many clients prefer to know what their total investment will be before committing to professional advice or representation. I charge upfront fixed fees. My aim in offering them is to give you peace of mind.

Below are the fees I typically charge for Public Access Magistrates Court Motoring cases. I will charge extra for my travel fares and hotel near court stay the night before your Hearing or Trial, should I assess this is necessary. I do not charge for other disbursements. There may be occasions where the complexity of the case may mean that that I need to charge more (or less) than the estimates below. <u>Because the following</u> are estimates, I will always give you a bespoke fixed quote by way of a formal proposal.

- 1. For Public Access Magistrates Court Motoring cases, my fees for written advice start at £999.00 (No VAT is payable). This is a popular option for people who want to represent themselves in court or get a second opinion.
- 2. For Public Access Magistrates Court Motoring cases, my fees for where you decide to <u>plead guilty</u> and need representation at your sentencing hearing are typically fixed at £1,049.00 (No VAT is payable). This fee includes a telephone or Zoom or FaceTime conference with you as well as meeting with you at court before your hearing.
- 3. If you decide to <u>plead not guilty</u> and need a Public Access Barrister to represent you at a Magistrates Court <u>half-day</u> or less Motoring trial, my fee is typically fixed at £1,549.00 (No VAT is payable). This fee includes a telephone or Zoom

or FaceTime conference with you - as well as meeting with you at court before your hearing.

4. If you decide to <u>plead not guilty</u> and need a Public Access Barrister for a <u>full-day</u> Magistrates Court Motoring trial, my fee is typically fixed at £2,499.00 (No VAT is payable). This fee includes a telephone or Zoom or FaceTime conference with you - as well as meeting with you at court before your hearing.

A word about "refreshers" and why I don't use them

A refresher is a fixed agreed fee for trials that are planned and listed to run for two or more days. Typically, a barrister would charge a higher amount for the first day – and then a lesser amount for the following days. Given that most Magistrates Court Trials and Hearings are listed for one day or less, I do not usually refer to refreshers in my contracts for services.

I typically draft contracts for my services for Trials and other Hearings to be performed on and at specific single dates, places, and times.

You should be aware that sometimes Magistrates Court Trials run over (go "partheard") their court allotted time and continue at later date. Other times, you may attend court as scheduled, but the court cannot deal with your case that day - or either you or the prosecution are granted an adjournment to another day.

Because I do not include refreshers in my contracts (unless your case is listed as a multiday Trial), if your case goes over to another date for any reason, a new contract for services between us for me to cover that new date (subject to my availability), with a further fee payable, will need to be agreed for you to secure my services for that later date. Usually, that further fee with be commensurate with the previous fee charged. Please contact me for a quote.

Other investment information

Upfront fixed fees are also available for other cases. Please contact me for a quote.

Some Public Access clients prefer for me to quote and charge an hourly rate. My hourly rate is £250.00 (No VAT is payable). If a period of work is less than one hour, I charge

pro rata in 6-minute units. One hour is my minimum fee. The agreed fee must be paid in full before I start working on your case.

<u>All Public Access fees are payable upfront</u>. I will not start working on your case until payment in full has been made and cleared funds have been received. Bank transfers and card payments are accepted. I do not accept payment by cheque. Details of how you can pay my fee are given after I have offered to take on your case and you have signed and returned my contract for services / client care letter.

My fees for instructions via solicitors will vary depending on the amount of work I am asked to do. All instructions via solicitors are taken subject to <u>THE STANDARD</u> <u>CONTRACTUAL TERMS FOR THE SUPPLY OF LEGAL SERVICES BY</u> <u>BARRISTERS TO AUTHORISED PERSONS 2012 (UPDATED FOR THE GDPR</u> <u>IN 2018)</u>.

I <u>do not accept</u> instructions under <u>conditional fee agreements</u> ("no win, no fee" agreements).

Timescales

Timescales for a case may vary depending on factors such as my availability, the type and complexity of the case, the other side's approach, and court waiting times.

I am sometimes available for last minute instructions – so it is always worth checking my availability.

Public Access

If you are a member of the public, the <u>Bar Standards Board's Public Access Guidance</u> for Lay <u>Clients is enclosed</u>. This will help you to understand how the Public Access scheme works and explains how you can use it to instruct barristers directly.

The Barristers' Register shows (1) whether a barrister has a current practising certificate, and (2) whether a barrister has any disciplinary findings, which are published on the Bar Standards Board's website in accordance with their policy. A <u>separate sheet</u> is enclosed which provides information about:

- My complaints procedure;
- Any right you may have to complain to the Legal Ombudsman (LeO) the independent body which can help you if you have complained to your lawyer and are not happy with their response;
- How to complain to LeO; and
- Any time limits for making a complaint.
